- ROADS Degner got a call regarding Terry Trail (Dan Burch). Degner had called and left a message this summer. They are looking to get this road work right away, however, they did not return a call after Degner left a message. The segment is about a quarter mile in length. Gravel is slightly less expensive than it was when quote was received in February. We need to let them know that they are responsible for all culverts that each driveway will be needing. Board discussed proceeding with the Terry Trail project as previously discussed at the February 2024 meeting. All roads could use a grading as things are getting rough. Pat has been working on the brushing and is making significant progress. Taubman spent some time and drove around and inspected signage and other items that could use some maintenance. 7 signs that need to be purchased. There are a couple of places that could use a double arrow. Some reflectivity issues on a few signs. Degner thinks that we should be looking to start training an individual to step in and help with the road work.
