- **AUDIT OF TOWN FINANCIALS:** Need to place an ad in the paper for quotes to receive an audit of the 2020 year.
- INTRODUCTION OF POTENTIAL CLERK/TREASURER CANDIDATES: Degner introduced Amber Anderson
- APPOINTMENTS OF CLERK/TREASURER POSITIONS: Motion by Damon to appoint Lesa Dahlstrom as Town treasurer, second by Kelbel. Motion carried. Yes (3) Degner, Damon, Kelbel. No (0). Motion by Kelbel to appoint Amber Anderson as town clerk. Yes (3) Degner, Damon, Kelbel. No (0). Motion carried.
- **PUBLIC INPUT:** Inquiry into the Little Long Lake Boat Landing. Taubman did speak with the DNR. There are grants available but generally are targeted towards larger boating vessels having access to the lake. Taubman was advised that there may need to be a permit obtained to change the landing. Taubman will keep working on this project and will proceed to the NCRS. Is there a target date of when the steps will be removed? It is anticipated that the steps can be removed within the next couple of weeks. John Smith asked if there were two individuals in the plow truck during the last snow storm and was wondering if they were town employees. Should a non-employee be riding in township owned property. Degner will check to make sure that the township is covered insurance wise with non-employee persons riding along or participating at town events. John Smith also asked about the grading and the watershed problem that may occur with a large rain. Taubman feels that all of the sod should be pulled up and ditches be cut in. John Smith also stated that his septic drainage runs right along the roadway and if the ditches were cut in it could affect his septic. John Smith asked if there is a reason why employees of the township are allowed to be speeding on Starkey Lake Road. Town board advised that if speeding is noticed that law enforcement should be contacted.
